# A REPORT TO THE COMMUNITY

ArtsFund turned 45 in 2014. We celebrated with a fantastic year of growth, focusing on community engagement, visibility and impact. At ArtsFund, we believe arts are everywhere and should be accessible to everyone. Through new partnerships and an increased community presence, ArtsFund supported the innovation and creativity of this region and built awareness of the value of art in our community.

ArtsFund supported over 80 arts and cultural organizations in 2014 through leadership, advocacy and grant making. We provided the cultural community with new and innovative platforms for marketing and fundraising, helping them expand their traditional capacity and outreach. We hosted unique opportunities for leaders in business and the arts to network and build knowledge. In addition, we grew our training programs for arts organizations, emphasizing collaboration, resource sharing, and strategy. ArtsFund training helps those organizations maximize available resources, leverage relationships, and deepen their message and value to our community.

We also expanded our funding initiatives in 2014. We invested \$2.55 Million in operating support grants to 55 arts groups representing a broad scope and many disciplines. And on October 1, 2013, ArtsFund launched a regional arts crowd-funding platform, [www.power2give.org/PugetSound](http://www.power2give.org/PugetSound), which, in its inaugural year, infused an additional \$420,000 in new funds for the arts through project-based support.

As we work on our long range plan and look towards our 50th year, ArtsFund is committed to continue increasing the ways we support arts groups in our region and strengthen our community. We invite you to join us.

# ALLOCATIONS COMMITTEES

For over four decades, ArtsFund has strengthened the community by raising funds from individuals and businesses to provide grants and other organizational support to the region's nonprofit arts sector. Through its widely respected allocations process, ArtsFund has distributed more than \$71 million in grants to a broad range of more than 70 arts groups throughout King and Pierce Counties. In 2014, ArtsFund awarded grants totaling nearly \$2.55 million.

Both donors and grant recipients trust ArtsFund's allocation process. The Allocations Committees comprise corporate and private grant making experts, and spend upwards of two full weeks evaluating application materials and interviewing the leadership of all applicant arts groups. They systematically rate each group against the same key evaluation points based on mission, financial stability, governance, and community impact.

On October 1, 2013, ArtsFund launched [www.power2give.org/PugetSound](http://www.power2give.org/PugetSound), a regional arts crowd-funding platform broadening the base of support for the arts by engaging and mobilizing new donors and funds.

Leveraging matching funds and technology, power2give/PugetSound raises visibility of the scope and impact of our region's arts organizations and allows them to build relationships with new donors while further engaging existing ones in project-based support.

power2give/PugetSound funds contribute to original programming and bring art to stages and venues throughout the state, provide greater access and unique experiences for both youth and adults, support arts education programs, fund artist commissions and residencies, and enable facilities improvements and enhancements to the audience experience.

# PROGRAMMING & ADVOCACY

ArtsFund's support of the arts does not stop with grants. As a central voice for arts in the Puget Sound region, the story we tell is how important engagement in arts and culture is to our quality of life, to education for our children and to our economy. In addition, we provide capacity and knowledge building programs, serve as fiscal agent and offer staffing support for audience building initiatives and networks, and advocate for the arts on local, state, and national issues. We also take a leadership role on broader initiatives that foster the future of the arts ecology in this region.

## ASSOCIATES PROGRAM

ArtsFund's annual volunteer corps equips individuals with fundraising and leadership skills and provides tools for civic engagement and nonprofit leadership. **In 2014, the team of 117 volunteers raised nearly \$450,000.**

## BOARD LEADERSHIP TRAINING

Our program strengthens arts organizations by teaching fundamentals of board service and providing practical internships with nonprofit boards. Over 650 current and future nonprofit board members have taken the training. **In 2014, 62 participants representing 39 civic, cultural and community organizations participated.**

## ECONOMIC IMPACT STUDIES

ArtsFund's Economic Impact Studies detail the importance of the arts and culture industry as an economic driver in our region. **Results from the study launched in 2014 will be released in 2015.**

## CONVENINGS

ArtsFund provides a platform for sharing resources, practices and perspective to expand capacity of the cultural sector. **In 2014, ArtsFund hosted convenings and webinars attended by participants from nearly 50 arts organizations.**

## CULTURAL RESOURCE COLLECTIVE

ArtsFund manages and serves as fiscal agent for the Cultural Resource Collective, a secure patron database used by 34 regional arts and culture groups to develop and maintain audiences.

## ADVOCACY

We are advocates for ongoing legislative initiatives such as Cultural Access Washington and Building for the Arts, which has secured over \$81 million for 194 capital projects at arts organizations throughout Washington State.

# ASSOCIATES PROGRAM

In 2014, 117 ArtsFund Associates from 70 unique companies raised nearly \$450,000 for arts organizations in the Puget Sound. The ArtsFund Associates program is a corps of passionate volunteers who come together to advocate for Puget Sound arts. Each year over 100 individuals form teams dedicated to generating support for the arts and cultural organizations that make our community thrive, while developing transferrable skills, expanding their networks across sectors, and of course, having fun!
